

ANNUAL REPORT Fiscal Year March 1, 2024 to February 28, 2025

In 2024-25, CHHA-BC continued to implement its Action Plan focused on three themes: Advocating for Accessibility; Communications, Awareness and Education, and Self-help and Sustaining CHHA-BC.

Accessibility and Advocacy

Under the theme of advocacy, we held an on-line session in July 2024 to provide feedback for the Provincial Government's consultation on accessibility standards. In January 2025, we intervened with the Canadian Radio-television and Telecommunications Commission about captioning for online streaming undertakings.

We held a meeting with Provincial Language Services in December 2024 and are working on increasing awareness of this free service. We have added this information to our website (<u>https://chha-bc.org/captioning-access/</u>) and our *Hearing Access Health Guide for people with hearing loss*.

Education, Awareness and Communications

As part of our second New Horizons project, we developed a workshop on Living Well with Hearing Loss. The first one was piloted in person in June 2024 at the Regency Southwood Resort for Senios' Week. Others were planned for in-person delivery in March 2025 in Prince George, Kelowna and Sidney. The workshop focused on communication strategies, resources and collaboration with CHHA-BC.

Our groundbreaking *The Way We Hear It! Exhibition* was held at the Albion Centre in Maple Ridge in May 2024. Project coordinator Jessica Niemela undertook to arrange videos of the exhibition as a lasting legacy. Numerous groups, including from schools, toured the facilities and several workshops were held in conjunction with the Exhibition including a Mix-n-Mingle educational event for employers and participants from the hard of hearing community, discussing workplace rights in Canada.



We also spent a considerable part of this year planning to host the third Exhibition in Prince George in May, 2025.

CHHA-BC participated in the *Impairments Open House* on April 15, 2024, hosted by the Maple Ridge Lions Club, whereby awareness about hearing loss was shared with the public. We were a guest speaker for a presentation to alumni, faculty and current students of the School of Audiology and Speech Sciences at UBC on March 5, 2025. We continued to highlight World Hearing Day of March 3rd by holding a joint online webinar with Wavefront Centre for Communication Accessibility. The theme for the session was *Ensuring Hearing Health for Living Well* in recognition of the importance of ear and hearing health.

Our Youth Peer Support Program included a Family Weekend Camp held at Camp Jubliee from September 13-15, 2024. Seven families and two young adult coordinators enjoyed outdoor and indoor activities, including a campfire sing-along following dinner. Many meaningful interactions and connections were built among the families and youth participating in the event.



Communications

The Loop, our electronic newsletter, was produced four times during the year. We launched a new social media strategy to enhance our online presence and engage more effectively with our community through <u>Facebook</u>, <u>Instagram</u> and <u>LinkedIn</u> in addition to our website.

In February, 2025, we conducted a membership survey, obtaining valuable feedback from interested persons. This was the first of such survey undertaken in the last few years.

We continued our liaison and mutual work with the Vancouver Branch and the North Shore Branch, the two remaining active CHHA branches in British Columbia.

Our annual fundraising campaign was affected by a postal strike which occurred at the height of the campaign, affecting the income generated during the campaign. We also continue to face challenges that telemarketing fundraising which relies on contact by landline telephones are not reaching audiences who rely on mobile phones. Regardless, our financial picture was buoyed by a substantial bequest. As well, we received grants from The Caldor Foundation, Provincial Gaming Authority, and Seniors New Horizons Program of the Government of Canada. We thank these sources for their support of CHHA-BC.
